To all the National Associations member of EFSMA

Dear Colleagues,

As previously communicated, the next EFSMA Council of Delegates will take place in **Antalya (TUR) on 16th October 2007, at h.14:00.**

The election of the EFSMA Executive Committee Members will be carried out with votes only being cast by the participating Official Delegates. Each vote will be recorded on EFSMA official paper and in a secret ballot. The names of the elected office bearers will be presented immediately after the count to all the representatives by the Election Sub-Committee.

In case of an equal number of votes for two or more candidates in a ballot where there are three or more candidates, a further ballot will be carried out, suggesting to the candidate with less votes to withdraw. Should two candidates have equal number of votes and in absence of a third candidate, then the President shall have the casting vote unless the election is for the position of President. If so, the Chairman of the Election Sub-Committee has the casting vote.

Please, find herewith the articles of the EFSMA Statutes related to the elections with the final list of nominations to the Executive Committee and the list of Official Delegates who confirmed their attendance at the Council to-date:

• EFSMA STATUTES

Article 9. RULES OF ELECTIONS

9. C. Election qualification. "A candidate for election shall be a representative of a member association of the E.F.S.M.A. duly recommended as such by the member national association which has paid the annual membership fee". Members of the Election Committee shall be ineligible to contest.

9. D. Qualification of voters. "All member nations shall be entitled to vote in the election of office bearers provided that the annual membership payment has been made by the rule of one fee, one country, one vote". There will be no proxy votes.

Article 8. FUNDS AND ECONOMY

8. E. "The annual membership fee shall be paid by the member associations not later than July 1st".

The Executive Committee decided that, for this year only, National Associations would be eligible to vote provided that their annual subscription was paid **by Friday 16th October 2009, h. 14:00**. All the National Associations were notified of this decision by the EFSMA Election Committee in the previous letter dated 1st July, in which it was announced the next Council of Delegates to be held in Antalya, and requested to send back the forms with the name of their Delegate to the Council and proposals of nominations to the Executive Committee.


